1. Your affiant, John Ziemba, is a Special Investigator with the Delaware Department of Justice and assigned to the Office of Civil Rights and Public Trust. I have been employed by the Delaware Department of Justice for one year. Prior to working with Delaware Department of Justice, I was employed by the New Castle County Police Department as a police officer and criminal investigator for 20 years.

2. During the course of this investigation, your affiant interviewed three Dewey Police Seasonal Officers, one part time Dewey Police Officer, two Rehoboth Beach EMTs and three civilians, all of whom were on scene at

the time of the incident.
3. On 8/10/19, at approximately 0011 hours, Officers from the Dewey Police Department responded to assist with an injured subject in the area of Bellevue Street and Coastal Highway, located in Sussex County, State of

4. Upon Officers arrival, the 26 year old male victim was located with an injury to the back of his head. Officers

were advised that the victim fell and struck the back of his head on a pole at the location.

5. Officers were told on scene that the victim lost consciousness for a short period of time and that his eyes were rolled to the back of his head.

6. While police and Rehoboth EMT s were rendering aid, the victim said that he did not want to go to the hospital. The victim's friends were able to convince him to walk to the stretcher with assistance so that the EMT s could look at his injury.

7. All nine of the witnesses that were interviewed advised that the victim agreed to walk to the stretcher with some assistance (due to his head injury and degree of intoxication) and sat down on the stretcher. The witnesses advised that the victim verbally advised that he did not want to go to the hospital. The witnesses advised that at no time was the victim physically combative.

8. All witnesses advised that the victim sat on the stretcher and one of his feet was still on the ground. The victim was told to put his other leg on the stretcher. The victim again stated that he did not want to go to the hospital

and did not move his leg.

- 9. At this time, Ofc. Gregory Lynch Jr. (DOB: 7/2/80) of the Dewey Police Department walked up to the victim and grabbed the leg that was still on the ground and put the victim's leg on the stretcher. The victim sat up on the stretcher and Ofc. Lynch pushed the victim back on the stretcher and punched him in the face several times with a closed fist.
- 10. According to multiple witnesses, Ofc. Gregory Lynch Jr. struck the victim with his closed fist approximately five (5) times in the face. Witnesses advised that Ofc. Lynch was up on the stretcher while he was striking the victim causing the stretcher to rise off the ground where the victim's feet were. Officers on scene advised that they had to hold the stretcher down, so it didn't completely flip.

11. Ofc. Gregory Lynch Jr. then handcuffed the victim s hands to the stretcher with the assistance of another Officer. Once the victim was handcuffed, Ofc. Lynch grabbed the victim from the neck and chin area and pulled

him into the ambulance.

- 12. Your affiant learned that Ofc. Gregory Lynch Jr. wrote and swore to an arrest warrant alleging that the victim committed Strangulation and two counts of Offensive Touching of a Law Enforcement Officer. Upon the victim s discharge from the hospital, he was arrested. The victim was given bail and incarcerated at Sussex Correctional
- 13. The victim was treated at Beebe Hospital and diagnosed with a concussion, a broken nose, multiple hematomas, and lacerations to his face.
